5. Period of deputation: In case of deputation, the period will be for three years.

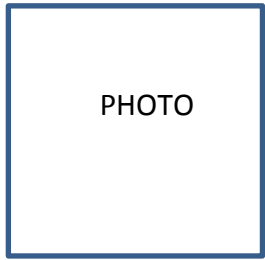
